# SOM-15 puts spotlight on Regional Plan of Action 2.0

#### Honiara, Solomon Islands, November 2019 -

The senior officials of the Coral Triangle (CT) Member Countries – Indonesia, Malaysia, Papua New Guinea, Philippines, Solomon Islands and Timor-Leste, gathered at the 15<sup>th</sup> Senior Officials Meeting (SOM-15) in Honiara, Solomon Islands from 7-8 November 2019. One of the significant items discussed was the draft Coral Triangle Initiative on Coral Reefs, Fisheries and Food Security Regional Plan of Action version 2.0 (CTI-CFF RPOA 2.0) which sets goals for 2025 through to 2030.

The CTI-CFF envisions that by 2025, coastal communities and coastal marine ecosystems are able to cope with impacts of climate change in the Coral Triangle region. By 2030, the communities and ecosystems will be resilient and adapt to impacts of climate change via improved food security, sustainable fisheries, and coastal livelihood.

The CTI-CFF proposes to focus on two flagship areas namely, the CT Marine Protected Areas System (CTMPAS) and sustainable Coastal Fisheries and Poverty Reduction Initiative (COASTFISH) designed to apply the Ecosystem Approach on Fisheries Management (EAFM). The CTMPAS visualizes a system of "networks" of MPAs and locally managed marine areas (LMMAs) that are connected, resilient, and sustainably financed.

The Committee of Senior Officials (CSOs) acknowledged the progress of the RPOA 2.0 as well as support from Development Partners throughout the development process. The CSOs have tasked the Regional Secretariat to facilitate the finalization of RPOA 2.0 early 2020.

The CSOs also accepted the accomplishment reports and the 2020 Workplans of the five (5) Technical Working Groups of Seascapes, Ecosystem Approach Fisheries Management, Marine Protected Areas, Climate Change Adaptation, and Threatened Species; the Governance Working Groups; and the Cross-Cutting Initiatives of Women Leaders Forum, Local Government Network and Regional Business Forum. The 2020 budgets for operations and activities were also approved.

Further, the CSOs acknowledged the improvement of the CT Atlas, a web-based online GIS database as well as approved recruitment of a M&E Manager.

The CT6 Member Countries also welcomed the new Executive Director (ED) of the CTI-CFF Regional Secretariat, Dr. Mohd Kushairi bin Mohd Rajuddin from Malaysia. This is in accordance with the CTI-CFF regulations that the ED will rotate amongst the CT6 Member Countries, in alphabetical order of the names of the countries, and will serve for a term of four years. Dr. Kushairi was a Professor and Dean at a private university (UNISEL) in Malaysia, prior to joining CTI-CFF. They also welcomed the new Deputy Executive Director for Corporate Services, Mr. Gustaf Adolf Lumiu

from Indonesia. Mr. Gustaaf previously worked as a consultant for UNDP and ASEAN Secretariat and other multilateral funding institutions.

The CT6 Member Countries of CTI-CFF also thanked Dr. Hendra Yusran Siry who temporarily served as the Interim Executive Director of the Regional Secretariat.

The SOM-15 was hosted by the Government of Solomon Islands and funded by the CT6 Member Countries with support from The Nature Conservancy (TNC), World Wildlife Fund (WWF), Coral Triangle Center (CTC) and the Pacific Regional Oceanscape Project under the Ministry of Fisheries and Marine Resources.


Prior to joining the CTI-CFF Regional Secretariat, Dr. Mohd Kushairi was a Professor and Dean at the University of Selangor, a private university. With over 35 years of professional/working experience, Dr. Mohd Kushairi specializes in coastal ecosystem management, rehabilitation and conservation of coral reef and island ecosystems.

He earned his Doctoral and Masters Degrees from the University of Newcastle-Upon-Tyne in England and received his Bachelor of Science in Fisheries from the Universiti Putra Malaysia.


Dr. Mohd Kushairi said that the contribution of each member country is needed and important to support CTI-CFF existence but emphasized the need for sustainable funding, especially from the private sectors and strategic partners.

He said that one of the ways is to involve the industry players of each member countries to share the role in sustaining the ecological importance of Coral Triangle. He added that recognizing the importance of ecological sustainability and involvement in maintaining it, a win-win situation will benefit the strategic partners between the governments and the industry players through their Corporate Social Responsibility, and the coastal communities of CT at large.

The new Deputy Executive Director for Corporate Services, Mr. Gustaaf Lumiu, also emphasized the need to mobilize resources by tapping various financial solutions and mechanisms such as

corporate responsibilities of private business, green mutual funds, and the like.

# Workshop on Gender Concepts, Analysis, and Tools in Sustainable Coastal and Marine Resources Management held

**Terrenganu, Malaysia, November 2019** – The Training Workshop on Gender Concepts, Analysis, and Tools in Sustainable Coastal and Marine Resources Management was held on November 19-21, 2019 in Terrenganu, Malaysia.

The workshop primarily targeted the government Malaysia who recently began developing a Gender Equality Act, which kicked off with a gender policy dialogue between the Ministry for Women, Family and Community Development and the Australian High Commission on May 2, 2019. Participants came from the selected government agencies, universities and international NGOs in Malaysia, as well as focal points Women Leaders Forum (WLF) from member countries of Coral Triangle Initiative. The Regional Secretariat was represented by Dr. Sharifah Nora Ibrahim, the Deputy Executive Director for Program Services who also served as a panelist for the Local Gender Networks.

The workshop aimed to equip participants with knowledge and skills on gender sensitivity and use gender analysis methods and tools; share regional, national and local initiatives on gender integration in coastal and marine resources management; increase understanding of gender integration at the organizational level; and recognize women leaders and gender champions in marine biodiversity and coastal resources management.

The sessions helped participants understand important concepts in gender and the use of different analysis tools to collect data, especially with respect to coastal marine resources, and how best to approach communities, women and vulnerable groups when collecting data.

Field visits included the Setiu wetlands and interviewing fisher women, weaver, etc in the community, as part of the Gender Resource Mapping Exercise.

The participants shared their insights, highlighting the needs and disparities within their own countries, and how best to use the knowledge gained upon returning to their home countries.

# First group completes CTI-CFF RCTNO Capacity Program

**Manado, Indonesia, December 2019** – The CTI-CFF Regional Secretariat's first intake/group of the Regional Coral Triangle Network Officers (RCTNO) has successfully completed the 5-month program on 13th December 2019 under the supervision of Dr. Gregory Bennett, the Technical Program Senior Manager of the Regional Secretariat(RS).

During the program, the RCTNO participants were immersed in the various activities of the Regional Secretariat such as Technical Working Group meetings, Pre- and 15<sup>th</sup> Senior Official Meetings as well as participation in national workshops. The RCTNO also had the opportunity to experience the culture of Manado, Indonesia by visiting some of its scenic spots.

The RCTNO is part of the CTI-CFF Capacity Building Program which aims to provide learning experience on improving the implementation of the current Regional Plan of Action (RPOA); to be involved and contribute in the renewal of RPOA process; to improve understanding of RS functions; to provide opportunity on improving and strengthening the linkages of NPOAs to the RPOA; and act as focal points between RS and their respective NCCs for communication assistance. RCTNOs were nominated by their respective CTI-CFF National Coordinating Committees.

The first group of RCTNOs are: Dr. Conni Sidabalok (Indonesia); Ms. Phelameya Haiveta (Papua New Guinea); Mr. Simeon Baeto (Solomon Islands) and Mr. Sabino Adonia (Timor-Leste). The RCTNOs presented activities being implemented in their respective countries toward the achievement of the CTI-CFF Regional Plan of Action (RPOA), issues/ challenges on the implementation of National Plan of Action (NPOA) as well as the lessons learnt and recommendations to improve the Capacity Building Program for RCTNO.

Dr. Mohd Kushairi Mohd Rajuddin, the Executive Director of the CTI-CFF Regional Secretariat expressed his thanks to these pioneer RCTNOs, particularly for their insights on the program and on how it can be further improved. Each RCTNO received a Certificate of Participation.

The Capacity Building program will continue in 2020. Application for the 2020 program will be opened soon and it is hoped all six Member Countries would be able to nominate a participant.

#### Honiara, Solomon Islands, November 2019 -

At the 15<sup>th</sup> Senior Officials Meeting (SOM-15) held in Honiara, Solomon Islands, the CTI-CFF acknowledged the contribution of Dr. Hendra Yusran Siry for his services as the Interim Executive Director (IED) of the CTI-CFF Regional Secretariat. The IED's term ended on 8<sup>th</sup> November 2019 upon the appointment of the new Executive Director.

During his 13-month term as the Interim Executive Director (IED), Dr. Siry continued to improve operations, transparency and accountability in financial management system of CTI-CFF Regional Secretariat (RS). With support from the US Department of Interior, he facilitated the process begun by the Acting ED and US DOI consultants, in strengthening Corporate Services to move from cash basis to accrual for more useful business analysis, easy planning and to make periodic financial statements that is more representative of financial condition of RS. He continued the reform recommended by the Consultant using a new accounting software, Xero, that provides real time financial reporting to stakeholders that can be accessed via website for transparency of financial expenditures and standing of RS. He also installed high security systems for the diplomatic zone of RS.

Dr. Siry also facilitated the process for the recruitment of the new Executive Director (ED) and Deputy Executive Director for Corporate Services (DED CS). He also continued to facilitate the process begun by the DED Program Services in 2018 on the renewal of the CTI-CFF Regional Plan of Action (RPOA 2.0). He also doubled the budget allocation for TWGs for the Year 2019.

He was also the originator of the Regional Coral Triangle Network Officers (RCTNO) capacity building program based on SEAFDEC's own program.

His leadership also helped CTI-CFF maintain its strong relationship with Development Partners and

**Townsville, Australia December 2019** – The CTI-CFF participated in the concluded 34<sup>th</sup> International Coral Reef Initiative (ICRI) General Meeting held in Townsville, Australia.
