Criteria for site nomination and inclusion to CTMPAS

Category 4 – Flagship Regional Sites	Exceptional regional importance in 3 components; highest level criteria for management effectiveness
Category 3 – Priority Development Sites	High regional importance; need further development and assistance
Category 2 – Effectively Managed Regional Sites	Contributing to CTMPAS objectives at national and regional levels
Category 1 – Recognized CTMPAS Sites	Contributing to CTMPAS objectives at local scale . . .

Nominations for Categories 3 and 4 go through a regional-level process conducted by a Regional Advisory Group. Regional MPA TWG has the final decision on which sites will be accepted into CTMPAS under Categories 3 and 4.

REGIONAL-LEVEL REVIEW AND SELECTION

COUNTRY-LEVEL REVIEW AND SELECTION

Nominations for Categories 1 and 2 are reviewed solely in-country by the NCC or its designated body, using the MPA assessment tool in place in the country. NCC will decide if a site meets National and Regional criteria for Category 1 or 2, and the CTMPAS TWG will respect the NCC evaluation and accept the recommendation.

2nd ROUND CTMPAS NOMINATIONS 2015

- × **February – Announcement**
- × **30th April – submission of nomination documents;**
- × **May-June - review process by the CTMPAS Review Committee;**
- × **August – recognition/confirmation of the 2nd batch of regionally significant MPAs.**

× Objectives :

3. To document and share best practices on MPA management in the Coral Triangle.

× Categories:

- × 1. Most Outstanding MPA (Outstanding performance in Governance, Biophysical and Socio-economics);
- × 2. Best in Governance (with outstanding strength/performance on jurisdiction, coordination, conflict resolution, M&E, Adaptive Management, Enforcement, Financing, Information management
- × 3. Best in Socio-economic (with outstanding performance on linkaging, learning networks, Best practices networks, awareness building, economic benefits to communities, climate change adaptation)
- ×
- × 4. Best in Ecology (with strengths on MPA size, MPA spacingg, habitat representation, resiliency by replication, connectivity, critical areas, species protection).

CTI-CFF MPA Roadmap Activities for 2014-2015 (Regional)

 - a. Announcement; b. In-country review; c. Submission of nominations; d. Regional review; e. External Review Group; f. Announcement of winners.

- B. CTMPAS nomination form shall be used (revised)

- C. Only MPAs under Cat. 3 & 4 shall qualify;

- D. Announcement and Recognition of Outstanding MPAs - every two years during CT Day/SOM/MM or other CTI related celebrations;

- E. Evaluators:
 - × MPA TWG, Advisers, MPA Coordinator, External Advisory Group;

- F. Recognition/Rewards:
 - × Certificate of Recognition
 - × Training/Study Tour
 - × Equipment
 - × Cash
