SOLOMON ISLANDS, 4-7 AUGUST 2015

- ➤ to ensure that management plan development process steps are appropriate adaptable to different settings aligned with management effectiveness tool applicable in the CT6 countries
- ➤ 31 participants of Community-Based MPA Managers; Ministry of Environment, Climate Change, and Disaster Reduction; Ministry of Fisheries; local NGO reps.
- ➤ training enables participants to develop marine area management planning in structured, realistic, and participatory way.
- ➤ 8 villages/communities were receiving knowledge and skill ro develop a management planning for their locally managed marine areas.

RIDGE TO REEF TRAINING

To build the capacity of the Coral Triangle MPA System and help MPA managers to develop actions for

- · improving the management of watersheds and reefs;
- protecting the food sources provided by watersheds and reefs;
- improving the health and well-being of both human and coral reef communities.

- ➤ support Ujung Negoro MPA to develop R2R plan






































R2R training involves activities to learn on how to read map, understand different types of activity along watershed, assessing impact, and align various observation into effective planning.

- Network of in-country trainers (PNG, SI)
- Women leaders (champion of village) raised awareness to more than 200 households (PNG, SI, Timor Leste)
- MPA Leaders enhanced MPA management effectivess
 - Developing and completing MPA management plan
 - Collecting biophysics basis data
 - Conducting socioeconomic survey
 - Conducting joint patrol and monitoring resource utilization

CTI-CFF Women Leaders' Forum:

3 national trainings in 3 CT countries as part of 6 national activities for the CTI-CFF Women Leaders Forum (one for each Coral Triangle country), successfully strengthening the capacity of more than 130 women across the Coral Triangle to take leading roles in marine conservation and natural resource management activities.

CTI-CFF Local government network

- Adoption of LGN organizational structure and the establishment of LGN Executive Committee make LGN to have an organizational vehicle for communication, member recruitment, policy making and developing roadmap.
- Support and potential resources for LGN Roadmap and strategy toward efficient and self-reliant LGN
- A wider networking among related local governments associations/networks at regional and international to support CTI CFF.
- Recruitment of 50 LGN members and more than 100 potential member identified
- Interim secretariat established at LMP

FROM THE POLICY ROUNDTABLES:

- Guidelines for sustainable tourism in the Coral Triangle could be largely built upon existing globally available guidelines, but with some tailored components specific to local conditions and revised to become relevant to all potential tourism related sectors, and accessible by all.
- These guidelines include those established by international organizations such as the Global Sustainable Tourism Council.

Challenges and Lessons Learned

Challenges

- Coordination of training activities
- Time commitment and travel budget of participants
- LGN government systems, communications, agenda, time-schedules
- Engagement business community remains difficult

Lessons Learned cross-cutting initiatives

- Targeted training very effective/ local co-trainer key
- Champions, initial strong support of CTI-CFF partners for the networks is key
- Alignment of international and national LGN and WLF activities
- Focused RBF with tourism theme effective
- Effective collaboration and leverage between RS, host NCC and partners

Recommendations

- Continue to engage key stakeholders in achieving the CTI-CFF goals (local government, women leaders, business community, youth)
- Mainstream CTI-CFF at international forums and ocean summits
- Support RS to coordinate the cross-cutting initiatives (capacity building, networks and forums)
 in collaboration with NCCs and partners
- Support RS with the coordination of a regional capacity building assessment and development CTI-CFF compendium on knowledge and training centers across the region

Work plan 2016

- Assist RS with regional capacity building assessment
- Training activities in Indonesia and Timor Leste
- MPA support in Indonesia (Sunda Banda seascape) and Timor Leste (Atauro Island)
- Expand MPA learning network (e-newsletter, on-line training)
- Support WLF and LGN activities
- Support NCC Indonesia with regional marine tourism taskforce
- Support RS with participation at international forums (World Ocean Council and International Coral Reef Symposium)
