






Message from the Executive Director

CTI-CFF REGIONAL SECRETARIAT AND STRATEGIC PARTNERS HYBRID MEETING

The CTI-CFF Regional Secretariat (RS) and Strategic Partners Hybrid meeting took place in Sanur, Bali over 2.5 days from May 10 to 12, 2022. The objectives of the meeting were:

- Learn updates on the RPOA 2.0 and associated plans, and planning for the acceleration of activities towards RPOA 2.0
- Review progress related to the three priority themes identified by the strategic partners (in 2021), and objectives developed at the USAID supported cocreation workshop (2022).
- Discuss next steps for accelerating progress in key priority areas for the CTI-CFF.
- Develop an agreed outline framework for moving forward that can be taken to the NCCs for further input.

The meeting focused around the three Strategic Initiatives endorsed at the Senior Officials Meeting (SOM) in December 2021, with progress reviewed for each initiative.

- The Conservation Trust Fund has progressed, with a steering committee established, preliminary trust fund design underway and strategic planning around the target support areas of 'Protect, Recover, Transform'.
- The Capacity Building RoadMap has progressed, with a CT-wide stock-take completed, and key RoadMap pillars and strategic activities identified.
- The International Policy Engagement initiative has identified key areas where analysis and further work is required.

CTI-CFF SAT IN THE PANEL ON INNOVATIONS FOR SUSTAINABILITY IN THE WORLD OCEAN CONFERENCE 2022

CTI-CFF participated in a panel in the World Ocean Conference 2022 entitled "Fisheries: innovations to the sustainability gap" close organized by the Economist in Singapore (29/11/2022). Moderated by Dominic Ziegler - Senior Asia Correspondent for The Economist, the session presented speakers from four respected organizations: Gloria Estenzo Ramos Vice President of Oceana from Philippines, Minako lue - Chief executive and Chair of Sailors for Sea from Japan, Essam Yassin Mohammed - Interim Director-General of WorldFish and acting Senior Director Aquatic Food Systems, CGIAR. and Dr Mohd. Kushairi bin Mohd. Raiuddin Executive Director of CTI-CFF Regional Secretariat.

The session discussed about the Asia-Pacific region as the largest producer of fish in the world.

The variety of fisheries are many, ranging from small-scale fisheries to large enterprises, which some parts of the industry cause immense damage to ocean health through overfishing and other damaging practices. However, some players understand the need for sustainable growth and work closely with the local fishing communities.

Each speaker brought up interesting topics such as the innovations that enable sustainable practices, how fisheries adapt to use of technology, and best practices available for fish stock management. CTI-CFF delivered a topic around the roles of Marine Protected Areas (MPAs) towards sustainable fisheries. Dr Kushairi spoke about CTI-CFF works with the MPA Working Group that aims to establish new MPAs and to improve the management through Coral Triangle Marine Protected Area System (CTMPAS).

The includes the launching of GFCR's REEF+ Knowledge and Finance Accelerator which was announced by Dr Chuck Cooper, Paul G. Allen Family Foundation, and presentation by CFA/ UNDP.

This session is directly in line with the anticipated Post-2020 Global Biodiversity Framework's action-oriented targets as well as supporting transitions to resilient nature-positive economies and financial flows; specifically leading mechanisms ready to deliver on Target 19.

RS PARTICIPATED IN BLUE CARBON WORKSHOP BY THE INDONESIAN NATIONAL PLANNING AGENCY AND PROVINCIAL FISHERY AGENCY

The Regional Secretariat was invited into a socialization event of the Implementation of Program Support for the Integration of Blue Carbon Ecosystems in Indonesia's Biodiversity and Climate Policies, in Manado, December xx 2022.

Representing RS were Mr. Solomon Sundah (ITO) and Mr. Michael Tampongangoy (NPPO).

The event was conducted by BAPPENAS and the ICCTF, with the support of funding from the Agence Francaise de Développement (AFD)—Fiche de Saisane de La Facilité 2050.

This project aims to integrate national and sub-national policies through the implementation of the Indonesian Blue Carbon Strategic Framework (IBCSF), the construction of the roadmap, the national baseline, the MRV (monitoring, reporting, and verification) of blue carbon, and the capacity building of national and subnational authorities in relation to blue carbon.

Manado hosts one of the Blue Carbon Project Sites among 3 dedicated sites in Indonesia.
